



## Tuition & Fees 2023-2024

In consideration of enrollment, please review the following Tuition & Fee structure for the 2023-2024 academic year, including the Withdrawal Policy. By finalizing your enrollment, you are agreeing to the pricing and terms listed within this document.

**Application Fee:** (Non-refundable) \$200 per new student. Due at the time of application. Note: In the event of a waiting list, those who have applied completely will be prioritized for space. Application is complete upon submission of online application and the payment of the application fee.

**Enrollment Fee:** (Non-refundable) \$300 per new student. Due at time of enrollment.

**Re-Enrollment Fee:** (Non-refundable) \$150 per returning student during Closed Enrollment January 10 – 31, 2023. Beginning February 1<sup>st</sup>, 2023, the late re-enrollment fee increases to \$300 per returning student. Failure to re-enroll during closed enrollment may lead to your student's seat being unavailable. Due at the time of enrollment.

**Payment Plan** \*Families who have children enrolled in Grace Christian School will choose a payment plan for GCS separately from the payment plan for GCCDC. CDC payment plans are limited to Weekly Payments Described below.

Weekly payments, are paid each Monday beginning the first Monday of August through the final Monday of July. (August 7<sup>th</sup> thru July 29<sup>th</sup>)

### Half-Day Preschool

Annual Tuition \$5,800 – Half-Day programming operates from 7:30 AM – 11:30 AM. Children can be dropped off after 7:00 AM & must be picked up by 11:30 AM. The half-day program provides breakfast, books and curriculum. This program operates in coordination with the Grace Christian School calendar. Note: priority enrollment is given to full-day students and the description of this program doesn't guarantee availability.

## **Base Tuition Inclusions**

Included in full-day programming are all books, teaching curriculum, FACTS software as well as most special classroom activities. Grace Café provides onsite prepared hot breakfast, lunch, afternoon snack and beverages. The Security portion of the tuition provides for School Resource Officer(s) (SRO). It includes continuing security maintenance and enhancements. Raptor Visitor Screening, Active Defender, Security Cameras, Controlled Digital Access system as well as technology filtering equipment are examples of currently implemented security measures.

## **Capital Facility Fee Inclusions**

The Capital Facility Fee covers the acquisition, upgrade and expansion of our facilities. It is set aside for special use in regards to property and building projects needed to sustain the ministry of Grace Christian Child Development Center.

## **Payment Policy**

**Late Payments:** GCCDC operates as a non-profit and depends on timely payments. A \$49 late fee will be charged by GCCDC in addition to return payment fees incurred by FACTS. Failure to pay as agreed will lead to the interruption of enrollment for your child(ren).

**Automatic Payment Method Required:** All Grace Christian Child Development Center billing and payments are processed through FACTS via the automated payment method of your choice. All families must have a valid and active payment method on file. **If at any point your automatic payment method becomes invalid/inactive, a \$100 fee will be assessed each month until a valid and active payment method is re-established.**

## **Withdrawal Policy**

Students are considered enrolled for the entire year; therefore, budgets and teacher contracts are set accordingly. Application and Enrollment Fees are Non-refundable. Students who withdraw any time after enrollment are required to provide a two-week notice. Failure to provide the required notice doesn't waive the liability of payment due. Submission of the withdrawal form confirms the withdrawal date.

## **Additional Fees** (as applicable)

**Preschool Graduation:** \$25 (K4 Graduates Only) – This fee covers on-campus graduation activities as well as Cap & Gown, Diploma and others costs associated with the graduation activities & ceremony.

**Transportation:** Transportation to and from campus is available in select areas and surrounding counties. Please inquire through the office for rules, rates and routes.

**Enrichment Programs:** GCCDC offers a variety of enrichment programs both after school and during the summer. Watch for communication with details of offerings and rates. Examples of these programs are ballet, gymnastics, music lessons and various athletic options.

**Incidental Billing:** There are areas of our program that require incidental billing. These charges may include, but are not limited to: spirit wear, fundraising charges, building access badges, and special event field trips. Typically, an emailed notification will be sent from FACTS when incidental charges are billed to your account. The email will include details of the charge, when the payment will be processed, and what payment method will be applied.
